He is doing all the work on Phase VI of the ODEQ project. He will also be helping with the rebuilding of some lift stations, the installation of an irrigation pump, and numerous other repairs with the sewer lines. He is a plumber by trade. Tonya said that Doug has been a great influence on the maintenance staff and he is teaching them various things.

David Ponder saved the land across the road when a fire started from a shorted electric line. He used a brand new back hoe in the fire to pull everything out and put the fire down. He was in that area fencing the 22 acres where the sprinkler fields are located.

## **ODEQ Committee**

Tom Elliott reviewed the Committee report (attached report). We had 2,200' of high pressure sewer line behind the lagoons that crossed over private and federal property which had to be moved. The new line has been run on Park property but still needs to be hooked up. A lift station will need to be built in DP to work with this.

We had a collapsed sewer line in the park that covered about 400' and this has been repaired.

The two small lagoons have been rebuilt and we are waiting on permeability testing to determine how much, if any, bentonite has to be added. Some plumbing has to be installed in these two ponds and this should happen next week.

There are 2 lift stations near CB-302 and the Park had a survey done in this area to be sure of where things are located and what actually needs to be done. The way the ODEQ drawings are setup and the way things actually are indicate we may be able to save about \$8,000 in just that area alone. He is trying to be mindful of the budget and trying to find things we can cut out, reroute and change and still stay within the permit.

Still doing maintenance work at the church. Had a good Sunday last week and felt that his message touched some of them. One attendee is going into the ministry in Oklahoma City. See their mid-month news attached below. There is a webpage for the church on the Cedar Blue website. It is under Discover CB.

## **10.** Entertainment Committee (see schedule attached below and on the web)

The Fall Carnival is on October 31<sup>st</sup>. There is a detailed agenda on the Cedar Blue website. They are still accepting silent auction items, prizes and candy and they can be left at the office anytime or at the Family Center on Friday night and Saturday morning. The funds collected from this event will be used to benefit the park.

There will be several activities some of which are a 50/50 raffle, costume contest, trick or treating with the golf carts, movie (the haunting of Veterans Lake), hayride and a petting zoo (large and small animals). A donation of \$600 helped pay for the petting zoo.

There will be a taco soup dinner from 5:00 - 6:00 pm. Free meal with donations accepted and asking folks to bring desserts.

They will be selling Cedar Blue T-shirts for \$15. The Entertainment Committee can still can use volunteers. They have about 25 so far.

## 11. Old Business-

- a. Group email system update Maggie Thompson has been successful in creating a group email system for the Park where announcements, etc. can be sent out quickly to property owners. Owners have to subscribe to this and can do so on the front page of the website (<a href="www.cedar-blue.com">www.cedar-blue.com</a>). Scroll down to the picture of the Park office and the sign-up form is to the right. When you sign-up it will send a confirming email to you which you need to verify. <a href="Sign-up sheets">Sign-up sheets</a> will be available at the Fall Festival where raffle tickets are being sold.
- b. Golf Cart Rules The Board is still working on this and plans to have a meeting soon to finish these up. Tom assured the owners this has not been dropped but the Board hasn't had the time to meet.
- c. Procedures for mailing and counting votes for elections A process has been developed and will be reviewed and voted on at the November meeting.
- d. Fire Department Tom told the owners he wanted to keep everybody informed as to what we are doing and why we do the things we do. As a reminder the Board voted to evict the Cedar Blue Volunteer Fire Department and that they were given 90 days to move out of the park. They are supposed to be out by November 15, 2015. He went on to tell them that there was a wild fire across the road this past week sparked by an electric line. After calling 911 the Sulphur Fire Department and Park Rangers responded quickly. In the meantime, David Ponder and his crew used their heavy equipment to pull the fire down and assist in getting the fire out. Approximately 45 minutes after the Sulphur Fire Department was onsite the Cedar Blue Fire Department responded. He noted that this was a prime example as to why the Board has evicted them. He noted that the Park is not able to depend on them for safety issues. Tom spent a good deal of time with the Sulphur Fire Chief about responding to the Park for calls and he was good to his word. It was also noted that when the 911 call went in both departments were notified at the same time.

## 12. New Business-

a. A security camera system has been installed inside and outside at the Family Center and laundry.

## 13. Property Owner's Comments

Joyce Guy (Sonshine Church) – She asked if the church could install a bell. She noted that it could be used if there is a fire or tornado as different tones can be set for different types of events. Board members told her they didn't have a problem with it. She also noted that the phone number they got for the church isn't working as there is no service inside the building. So they are using their home number which is posted on the website. Gerry Batt told them that since they are with AT&T they should be able to get a piece of equipment (wireless) that they can put in the church that allows them to get their home phone number at that location as well. There is a nominal monthly cost for this.

<u>Vicky Coy (CC-015)</u> - She thanked the Board for all their hard work and the great job they are doing. She knows this is a volunteer job and time consuming.

<u>Curtis Oshel (CC-095)</u> – He asked about the cell phone tower. He was told it was believed that ATT put up a cell tower elsewhere. The Board thinks that another company may be interested in the contract. Curtis Oshel was asked to follow-up on this.

Jerry, Warren, Doug and Bobby have repaired water leaks in Cedar Creek, Cedar North, Cedar Ridge, Deer Path and Cedar Blue areas of the park. Warren sprayed for weeds behind the lagoons and closed off the road so no one would dump trash and unwanted items in that area. Everyone has been hauling tree branches weekly to the limb yard.

Bobby & Warren cut down approximately ten trees at the Volley Ball court area to make clear for new fencing to be installed by Five Point Construction. Bobby cleaned up area again once fence was installed. Bobby & Warren rebuilt a temporary cap for the lift station behind CN-004.

Jerry and Doug have been working many hours identifying water and sewer line locations for Phase VI of the ODEQ project. Jerry and Doug replaced a sewer line that ran from CB-318 to CB-312 (about 400').

Two washers and dryers have been purchased for the laundry room at the Family Center. Jerry, Joe and Tom worked together setting up. Price to wash is \$2.00 per load and \$1.50 to dry. It is nice to have new appliances and we strongly encourage all property owners to take great care when using. Jerry, Doug and Tom worked together installing ballasts and light bulbs at the Family Center. We even have a new ceiling fan in the laundry room. Yea!!

Joe painted the fencing and poles at the entry and exit to the electronic gate. Bobby, Warren, Joe & Jerry have been weed trimming and mowing all over Cedar Blue. Our staff has been doing a fantastic job!! Please let them know how much we appreciate what they do.

With regards to the infrastructure to Cedar Blue, the committee members are putting together ideas for: replacing and repair of the roof and structure of the Family Center, fix up the bathrooms in the pool house, redo the bathrooms and kitchen in the Family Center, repair and maintenance to the roads and painting the Park's water tower.

## 1. Accomplishments:

- a. The two small lagoons have been dozed out and construction of the new lagoons is proceeding very well.
- b. Curtis Oshel is working out details with OG&E for new 3-phase power at the lagoons for the irrigation pump.
- c. The fence around the 22 acres across Cedar Blue Road is completed.
- d. The first part of phase VI is completed. This required that 60 areas, identified by the ODEQ, in the park be dug up to measure the distance of the fresh and waste water lines from each other. The digging has been completed and all the information on which of these areas need to be fixed has been gathered. Now a report needs to be prepared for the ODEQ. Some repairs have begun on the critical areas.

#### 2. Future Activities

- a. Tom Elliott will meet with the Park's engineer the week of October 12th to finalize the Phase VI report to ODEQ.
- b. Tom is still waiting on an answer from ODEQ about the status of easements. Over a year ago the property owners were asked to sign easements for this project and not all were willing to sign the document. Easements are covered in the Covenants and Bylaws and therefore, the ODEQ Committee has asked the ODEQ for clarification on the easements set forth in the Covenants and Bylaws versus the easements the owners were asked to sign.
- c. The Committee is optimistic that there will be enough funds in the Infrastructure account to not only complete the lagoon work but to complete all the Phase VI repairs in the next several weeks.

A big welcome to Doug Washburn!! Doug has been working diligently locating water and sewer lines for the phase VI project. A big thank you to David Ponder and his guys for all their hard work on the lagoons and other areas and to Nub Sullivan for the use of his track hoe. Without it Phase VI would not be as far along as it is.

I have spoken to Phil Hurst regarding the foreclosures. At this time all five of the properties have gone through and completed the process of notification by publication. Anyone who has a claim to bring forth may do so until Friday, October 30, 2015 @ 4:30 pm. A final default judgment will be filed within the first two-three weeks of November 2015. Once the judgment is filed there is a hearing with the judge to grant the default judgment. Next, an appraisal of each property is taken within 30-45 days. Once the appraisal process has occurred, there is a hearing before the judge to grant a date for the foreclosure at the courthouse. Per Mr. Hurst, this process will take us into January - February 2016.

I have spoken to Deputy Ben Flowers of the Murray County Sheriff's department regarding the office thefts. He is trying to arrange a time to interview with the suspect and that individual's attorney. Mr. Flowers hopes to have an update for me next week. After the interview, he will write a report that is then sent to the DA for review.

Please remember the first half of the Infrastructure Fee (\$107.50) is due Monday, November 2, 2015 at 5:00 pm in the office.
